- Outline the apparatus and/or materials used in your chosen study. (OCR Psychology AS Unit 2; 8 marks)

### 10 mark qns

- Emily is a psychologist who is interested in the effects of noise level on children's concentration. To test her hypothesis, Emily uses stratified sampling to select students from a pool of schools in London. She uses a repeated measures design.
  First, participants are asked to read a passage in a noisy environment. Emily then tests their memory of the passage. Then, she puts all of the participants into a room that's quiet and has them read another passage. Emily then tests their memory of the passage in the quiet environment and compares her results.
  - a. Evaluate the reliability and validity of Emily's study. (OCR Psychology AS Unit 1; 10 marks)
  - A research team want to replicate Emily's study, looking at how noise affects memory recall. Describe and evaluate a way to measure 'memory recall' that could be used in this study. (OCR Psychology AS Unit 1; 10 marks)
